

# 2024 Nonprofit Sector Report

### **Utah's Nonprofit Sector**

Total Number of Tax-Exempt Entities: 11,611



Utah's nonprofit sector has seen steady growth, both in the total number of tax exempt entities as well as in total revenue and assets.

In 2023, Utah was home to 11,611 501(c) organizations, with 9,888 501(c)(3) charitable organizations.



### Year Over Year Growth in Number of Organizations and Total Revenue



The Nonprofit Sector comprises 6.7% of Utah's workforce, about 115,000 individuals. While Utah has the nation's highest rate of volunteerism, it also has lowest number of nonprofits per capita in the country.

The majority of organizations are located in Salt Lake County (5,202), Utah County (1,668), Davis County (867), Weber County (798), Washington County (637), Cache County (426), and Summit County (412). Over 90% of nonprofits in the state operate on small budgets, with less than \$500K in annual revenue.



#### Nonprofits by Revenue Range

The majority of tax-exempt organizations in Utah (71.6%) report 0 revenue. This includes organizations with less than \$50,000 in gross receipts, religious institutions and affiliated entities, political committees, and some private foundations, which are exempt from filing annual disclosures. Nonprofits with \$100,000 to \$500,000 in annual revenue form the next largest grouping (9.8%), followed by \$25,000 to \$99,000 in revenue (6.1%), and \$1,000,000 to \$4,999,999 (4.1%) in revenue. Organizations with revenue over \$5,000,000 form 2.6% of all nonprofits.

#### **Composition of the Sector**

Utah's nonprofit sector is primarily composed of 501(c)(3) Charitable Organizations, followed by a small percentage of 501(c)(6) Business Leagues, 501(c)(4) Civic and Social Welfare Organizations, and 501(c)(12) Mutual Corporations/Associations. Additional designations include Agricultural and Labor Organizations, Social Clubs, Fraternal Societies, and Veterans Organizations, among others.


